# **NAC CRITERIA**



# Moderate Impairment:

The visual acuity of a pupil is 20/70 or less in the better eye with the best possible correction; or

The pupil suffers from progressive deterioration of the pupil's vision, the probable result of which will be the condition described above.

#### **Severe Impairment:**


The visual acuity of a pupil is 20/200 or less in the better eye with the best possible correction; or

The vision of the pupil in the better eye is restricted to a field which subtends an arc of not more than 20 degrees; or

The pupil suffers from a progressive deterioration of the pupil's vision, the probable result of which will be one or both of the conditions described above.
